During March two farms in Appledore Road and Plurenden Road had items stolen from inside locked buildings. A Tractor unit was recovered later from farmland in Smarden. There was no anti-social behavior reported in the ward during March.

There have been several thefts of heating oil and garden tools from sheds in the district. Items can be protected by property marking and inexpensive locks and alarms.

Oil tanks, sheds and outbuildings can be protected with inexpensive alarms and locks. I have conducted visits to several residents and given crime prevention advice to help protect their homes and business's.

There is a temporary KCC Warden who is covering Woodchurch as well as her main patch of Hothfield and Bethersden. She can be contacted on 07813 711940 but obviously she is dealing with a very large area at the moment.
