# 5. MEETING ADJOURNED FOR PUBLIC PARTICIPATION AND RECOVENED

The meeting was adjourned from 7.03 to 7.26 during which time Mr Sparkes reported that he is a member of Ashford Borough Council's Planning Committee and one development in Woodchurch is causing concern. A neighbour is very concerned about the change of use to

Unit 1. Mr Sparkes is in contact with the Planning Officer and is looking into the time restriction as the proposed extension to the hours will increase the traffic movements from 4-5 to possibly 30. The hedges are not kept cut back and Mr Sparkes has asked for a site visit with a member of Kent Highways and the Planning Officer as he is concerned that the poor visibility could potentially lead to a fatal accident.

Councillors informed Councillor Sparkes that they are concerned that the application for the Lower Road development now encompasses the entire area.

A resident put forward his concerns regarding his neighbour's planning application.

The Speedwatch Co-ordinator informed Councillors that 6 residents are undergoing training and should be ready to start after 8 July once the 8 designated sites have been registered.

# Extension of Village Green - Transfer of Land

#### Churchyard

The group members would like to purchase a banner advertising the project and asked whether the Parish Council would agree to it being put on the play area fence a few days before each Volunteers Weekend. Councillors unanimously agreed to this request.

Council should meet with new tenants to discuss the problems experienced by previous landlords.

#### **Future of the Woodchurch Hub**

Then new opening hours start on 1 July. The Centre will be open every day from 10 am - 4 pm and on Saturday mornings when there is a Coffee Morning in the Memorial Hall.

Discussions are taking place with our new Borough Councillors regarding the possibility of them holding a surgery on a regular basis in the Hub.

#### **Renovation of Benches**

Mr Jarvis is continuing to renovate the benches when the weather permits. Most of them are finished.

Two benches were delivered a couple of months ago and need siting around the village. One will be placed in Lower Road.

#### Woodchurch in Bloom

The judging takes place on Monday.

#### **Community Transport Scheme**

There has been a delay in the launch. The bus is now expected at the beginning of August and Mr Jones continues to liaise with ABC and updated Councillors on the progress to date;

The bus has been ordered and we have 25+ drivers. We are not sure whether they will need a DBS check if they are driving for their own group or society.

Dr Hickey has agreed to undertake the medicals free of charge for those drivers aged 70+.

Mr Jones is in consultation with Blue Light Training regarding a date for the training. Councillors agreed the following:

<u>Resolution</u>: Councillors unanimously agreed to draw the cheque for the Blue Light Training, payable to the WCIE. This will be reimbursed when funds permit.

In terms of payback, as we were expecting the bus in May but will not take delivery until August, we need confirmation from ABC that they understand that it might not be used as much as it would have been, had we had it for the whole summer.

The artwork was discussed and agreed.

#### Proposal to Purchase a Climbing Frame for the Play Area

We have been unable to find a frame of commercial standard and size that will fit into the play area.
