Self Insurance of Fixed Assets:-

Resolution: Councillors unanimously agreed to self-insure all the benches, notice boards, flag pole, flags, oak posts, Ranters Oak Memorial, chestnut fencing, metal posts, metal and wooden litter bins, Memorial Hall Sign, Disabled Parking posts and sign, wooden barrier to side of toilets, kissing gate, filing cabinets, iron water pump, war memorial, stench pipe, tourist signs, dog bins and other sundries as listed in Fixed Asset Register.

Mr Robinson confirmed that he has checked the insurance documentation and is satisfied that all is in order.

Resolution: Councillors unanimously agreed to continue to insure with Aviva. Premium £627.50.

- 5 x potholes along Front Road between Glebelands and The Bonny Cravat Pothole outside 60 Front Road


