EMAIL CORRSPONDENCE

Councillors do not wish to take part in the Bagged Salt Trial.

KHS contacted us regarding the overhanging Willow Trees at the bottom of The Green on Front Road. Mr Robinson will contact a Tree Surgeon to discuss this and report back.

Mr Robinson brought the attention of those present to the email in which it stated that the length of a sewer between a property and the road is no longer the responsibility of the owner of the property. He will also write to Southern Water regarding sewerage problems in the village.

Mr Cridge sent Mr Robinson an email he received from a resident offering free trees. Councillors were asked for ideas as to where the trees could be planted.

Following the scoping report regarding Pond Farm, Mr Robinson and Mr Cridge met with a representative of Fridays and they appear to have taken note of all our concerns. All trailers will now be covered when they are brought through the village. We objected to the 190% increase in the number of sheds and they are now only proposing a 40% increase. They are also addressing the issues regarding the increased amount of traffic. An Environmental Assessment will have to be undertaken.
