8. **FORUM FOR EXCHANGE OF INFORMATION BETWEEN COUNCILLORS**

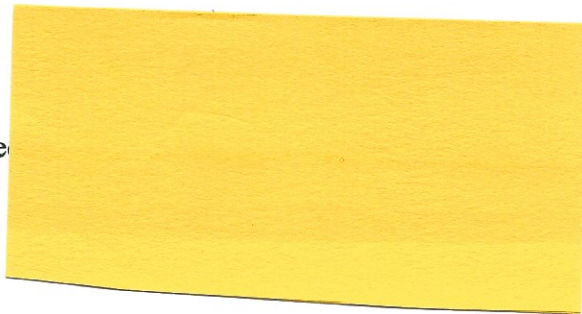

Comments sent to the Planning Officer at Ashford Borough Council:-

Woodchurch Parish Council met last night and discussed the following application:-

10/01580/AS Mr A Best, re Land at North West of and adjoining, Shirkoak Park,  
Woodchurch, Kent  
New sewerage Treatment Plant including grassed irrigation plots to replace  
existing facility and double door kiosk.

The members of Woodchurch Parish Council agreed to support the application but would like it to be referred to the Planning Committee and for them to take the following comments into consideration:-

1. The land which has been used for the sewerage plant is agricultural land, but there has been no change of use application.
2. The Sewerage Consultant has stated that the grass on the sewerage beds will be cut and removed from site at least 3 times a year. Councillors would like to know why it needs to be removed. Is the land being contaminated?
3. There has been no Wildlife Ecology Survey.
4. There are serious concerns that despite the Environment Agency's statement to the contrary, the effluent being discharged into the ditch on the Bethersden Road is not up to a dischargeable standard.
5. Serious concerns were also expressed that the work has been carried out prior to planning consent. Under the court judgement, sewage could have been removed from the site by tanker until proper consideration had been given to the planning application. Councillors would like to know what action ABC is taking to address this.
