Mr Robinson reported that, with Councillor Davison, he had met with Mr Bunnett and Mr Vink at ABC to discuss planning concerns within Woodchurch.

With regard to the problems with water at 42 Front Road and the fact that the strictures put in place by the Inspector have not been adhered to, Mr Vink promised to do something, but said he is experiencing problems as ABC does not have enough Enforcement Officers.

The situation at the Stonebridge with regard to the permission now being for 80 rooms was discussed. Mr Robinson pointed out that if similar problems arise to those being experienced at 42 Front Road, the Parish Council will complain to ABC.

Although ABC stated that they were unaware of the fact, Cornerways has been demolished and numerous complaints have been received regarding the fact that the roofing material has been deposited on the highway. The Parish Council have paid Mr Norris to clear it up as concerns were raised about the children walking through it on their way from school.

An email has been received regarding Maiden Wood. The Clerk will respond explaining that an Article 4(i) has been issued.

Dr Busk contacted Mr Robinson with a proposal to build 4 affordable houses on the site originally proposed for an extension to the surgery.

Following an article in the Kentish Express, the Clerk was asked to write to ABC and ask them to take the same action over Shirkoak Park as they have taken with the Mobile Home Park at Biddenden.
