The Green

Mr Robinson will ask Mr Grabham to spray the area around the toilet with weed killer.

Mr Robinson will discuss re-seeding part of the football pitch and the health and safety concerns regarding the storage of the goal posts when not in use with Mr Davy.

KALC

Mrs Haynes reported that the Chairman and Vice Chairman had a positive meeting with the Leader and Chief Executive about different issues, including the timing of the Parish Forum.

The issue of Localism was discussed at the Parish Forum on 20 July.

The Handyman Scheme is being tried out in the Aldington and Bonnington area to see if it will work. The idea is that each parish employs its own Handyman, rather than relying on ABC. If the scheme is successful, parishes will have to purchase their own equipment. The Handyman will be paid the minimum wage.

Mrs Wood, the Clerk for Brabourne, Smeeth and Westwell has replaced Mrs Batt as Secretary.

Provided they have been received, the replies to questions sent to the Police will be discussed at the next meeting.

The concerns over the contracts for retained firemen and response times by the emergency services in rural areas will be discussed at the KALC AGM on 12 October, as will verge cutting and spraying.

The parishes will continue to receive plans on paper.

There is a lack of Parish Councillors across the Ashford Borough.

The pothole in the middle of the road outside Keepers End.


The kissing gate on Footpath AT233 does not latch.
