# 5. MEETING ADJOURNED FOR PUBLIC PARTICIPATION AND RECOVENED

Local residents are angry because the Planning Department has not followed up on the refusal of the recent application and 3 units have moved onto the land. Mr Ledger is investigating the matter and being kept informed by officers at ABC.

Mr West was contacted regarding the fact that the owners of 43 Front Road were refused permission to have a dropped kerb installed, but the kerb has been lowered on both sides of the road a few yards away. Mr Ledger reported that he had had a site meeting and KCC won't allow the dropped kerb because of the site line. He thought the site for the dropped kerb had been agreed and will contact our County Councillor, Mr Angell and ask him to investigate this matter.
