#### The meeting adjourned for public participation

A member of the public raised concerns about the lack of clarity regarding overnight parking in the village car park.

Cllr David Ledger congratulated Cllrs Ciaran Molloy and Wade Nash for their contribution during the recent Gladman planning application appeal. Throughout the appeal Cllr Molloy put excellent arguments forward. Cllr Ledger reported that as part of the Climate Change Committee's commitment social houses will be brought up to C energy efficiency. There are a number of planning appeals. The Government now allows more permitted development to enable the installation of telephone masts. Cllr Ledger noted the importance of attending KALC meetings. At the recent KALC meeting the Head of Planning was present who gave a brief update regarding the progress of the recent planning portal upgrade. All Clerks will be contacted, and councils asked for feedback on their experience of the new planning portal. There are a number of training events planned, one on the 18<sup>th</sup> of October, there will be opportunity for both physical and virtual attendance. The Scrutiny committee will carry out an investigation to find out what went wrong during the roll out of the new planning portal. Cllr Nicola Job reported that she found a number of errors when looking at historical planning applications. The new Police Chief Inspector was present and explained that they face budgetary constraints.

#### 11.1.1. Planning Application Number 22/01093/AS

Applefield, Redbrook Street, Woodchurch, Ashford, TN26 3QS A domestic scale photovoltaic ground mount array consisting of a steel framework fixed via ground screws with 14 solar panels (113.5cm by 227.9m) creating one single row of panels 16m long and 2.2m tall, with a surface area of 32m2. All associated cabling to be in 5cm diameter plastic conduit buried in a 60 cm trench.

The proposal does not impact on surroundings. The parish council agreed to support the application.

#### 11.1.2. Planning application reference PA/2022/2256 and PA/2022/2291

Site Address2, Drayson House, The Green, Woodchurch, TN26 3PB Proposal Removal of condition 3 (the proposed accommodation shall be used only for residential purposes ancillary to the property known as Drayson House as indicated on the plan accompanying the application) on approved planning application 90/00476/AS (Proposed Conversion and Extension of Old Stables into Flat for Dependant Relatives and Bedsit for Nanny/Nurse) to enable full use of annexe for holiday let and refugee lodgings. Second application: Current obligation restricts the use to dependents only. The applicants wish to be able to use the annex unencumbered.

The Parish Council agreed to support this planning application on the proviso that subsection 2 of Condition 3 is retained.

#### 11.1.3. Planning application reference number PA/2022/2277

37 The Green, Woodchurch, Ashford, TN26 3PF Resubmission of 22/00744/AS Proposed new chalet bungalow along with associated works in the front garden of 37 The Green

The Parish Council continue to object to planning application PA/2022/2277 (formally 22/00744/AS), 37 The Green, Woodchurch, TN26 3PF re "Proposed New Chalet Bungalow within the front garden of No 37", for the following reasons:

• The proposed development to be located within the "front garden" of no 37, is actually directly in front of No 37a, south east of No. 37, east of No 35 and west of the 16th Century Place Farmhouse. The site is within Woodchurch's Conservation Area, the centre of the Village, adjacent to and overlooking the Village Green and close to a number of other white weatherboarded Grade II buildings. We believe that the proposal will not preserve or enhance the visual amenity within the conservation area of Woodchurch as the new design continues to be overbearing with respect to adjacent properties and will obstruct the direct view from the village green towards the Grade II listed Place Farmhouse. It will consequently impact the attractive Wealden rural nature of Woodchurch Village, its open (green heart) character and adjacent heritage sites.

• The design, materials and visual appearance will not form a balance with adjacent properties as the majority are weatherboarded and painted white. The adjacent 16th Century Place Farmhouse was initially similarly faced but then brick faced in the 18th Century using local materials. Construction of a modern house using modern brick face is not deemed appropriate for that part of the conservation zone.

• We consequently believe that it contravenes of a number of Policy's within the 2030 Ashford Local Plan, namely:

- Policy ENV14 (a, e and f);
- Policy HOU3a (a, c and d);
- Policy HOU 5 (e & f).

• There is a potential concern with respect to noise and disturbance due to the siting and operation of the proposed air source heat pump.

• Provision will need to be made for the existing sewer pipe to be re-routed around the new building.

• The question of vehicular easement across Parish Council lands needs to be clarified.

• The protection programme for boundary hedges and adjacent trees needs to be clarified.

#### 12. Planning Decisions

#### 12.1. Report on status of Gladman Appeal

Cllr Molloy gave a brief update on the recent appeal hearing held on 04<sup>th</sup> October attended by Cllrs Molloy and Nash. A decision by the inspector will be made in 2-3 weeks' time. Cllrs Molloy and Nash were thanked for their help and providing local knowledge. It was noted

that the local infrastructure capacity is not adequate to accommodate new developments in the village. It was agreed to seek confirmation from both the surgery and school of their capacity. Consideration to dental care should also be given.

# 12.2. Brief update on Appledore Road Appeal

The proposal is to build 31 dwellings. The appeal is in progress for non-determination. The proposed development is too dense. The proposed location for social housing is concentrated in the bottom of the proposed development corner.

#### 12.3. Update on Kirkwood planning proposal following a site visit

The application for the three dwellings has not been determined yet. The decision is delayed as the applicant couldn't demonstrate who will mange the proposed ecological land. The developer has approached the parish council and offered to gift the land to the parish council. The question remains regarding who would manage the land. The Parish Council had a factual site visit and met a representative of CS Developments. The representative confirmed the ecological land could be gifted to the council. It was suggested that CS Developments present their plans at an open public meeting to allow residents of Woodchurch to ask questions. The Clerk to check if the insurance covers legal aid.

#### 13. Finance

The parish council has agreed to approve the items on the list of payment with the addition of the outstanding payment to the litter picker for August and September. The Clerk to print off a copy of the list for the chair to sign.
